## 1. NAME OF TRUST:

The Name of the Trust shall be "AZAD FOUNDATION"

## 2. REGISTERED OFFICE:

The Principal office of the Trust shall be situated at K-50,51, S-03, BALAJI ENCLAVE, GOVINDPURAM, GHAZIABAD, UTTAR PRADESH 201013 or such other place as the Trustees may from time to time, decides. The Trust may also carry on its work at any other place or places, as decide by the Trustees.

**Note: This office is not the property of Trust and No other property is invested in the Trust.**

## 3. MAIN OBJECTS: The objects for which the Trust is founded are:

- 3.1 To provide education by establishing Schools, opening of Institute, Study Circle, Training Centers, Vocational Colleges, Professional Colleges and thus create employment opportunities to the disabled, orphans and economically backward class people. Prominence will be given to Rural Party of the Society and Homes for old age people.
- 3.2 To establish, setup, and run in any part of India coaching institutes, Study center, oral coaching classes, where in professional, technical, vocational or higher education in every field, part time classes.
- 3.3 To establish, develop, promote franchise, study centers in India or abroad for conducting regular, evening or weekend interactive classes and to get the necessary approval, permission required for this purpose.
- 3.4 Establishment, Running and maintenance a school, Institute, Study Circle Training Center for poor, needy and deserving student of public at large.
- 3.5 Establishment, maintenance and support of studentships and a scholarship for poor, needy and deserving students and scholars of the Institute, Study Circle, schools, colleges, universities and other educational or technical institutions;
- 3.6 Paying to needy students, Institute Fees, school fees, college fees, books, Instruments, tools etc.;

- 3.7 Subscriptions, contributions and/or donations to any schools, colleges, Institute, Study Circle, public funds, orphanages or other public institutions for advancement and propagation of education and knowledge and for promotion of any public charitable objects.
- 3.8 To conduct research in education and other different subjects relating to education.
- 3.9 Paying whole or part of educational costs of deserving students;
- 3.10 To accept managing committee including its chairman, Manager and members of school.
- 3.11 To organize seminars, meetings, Press-conferences and other lawful gatherings from time to time.
- 3.12 To open, found, establish, promote, set-up, run, maintain, assist, finance, support, and/or help in various charitable, educational, technical/non-technical, industrial, vocational and agricultural institutions.
- 3.13 To promote literacy culture and other social activities by awareness Programs, adult Education Classes, Sarv Sikhsha Abhiyan, Lectures, Essay, Competition, Exhibition, Symposiums, Cultural Programs, press Conferences and Seminars.
- 3.14 To provide food, cloths, medical aid, stationery, transportation, libraries, laboratories, reading rooms, hostels, play grounds, swimming pools and other possible facilities to students and also to the member of the trust.
- 3.15 To organize and take up Educational and Welfare programs for needy Person on priority basis.
- 3.16 To promote, encourage and facilitate research programs and trainings in the field of public health, education.
- 3.17 To institute scholarship and help to deserving students and to institute and award prizes for their excellence academic performance.
- 3.18 To provide free / concessional educational to the hopeless, poor and needy children, specially to the handicapped children.

- 3.19 To borrow or receive money (with interest or without interest) and upon such terms and conditions as are approved by the Governing Body of the Trust.
- 3.20 To engage, employ or hire appropriate staff workers, legal experts and other professional, attorneys, managers and agents for the work and furtherance of the aims and objects of the Trust and to pay their wages salaries, stipends or fees.
- 3.21 To accept donations, grants, presents, gifts, and other offerings in the shape of moveable and or immovable properties for the attainment of the aims and objects of the Trust.
- 3.22 To purchase/ acquire the land and/or the building in the name of the Trust for the upliftment and fulfillment of the Aims and Objects of the Trust.
- 3.23 To erect, construct, alter, maintain, self-lease, mortgage, transfer, improve, develop, manage and control all or any part of the property or the building of the above Trust, necessary or convenient for the purpose of the attainment of the Aims and Objects of the trust.
- 3.24 To arrange and manage the various vocational training centers for development of women and girls like tailoring and cutting, weaving, typing, short-hand, modeling, fashion, designing, toys making, beauty parlor course, mendhi designing, hand weaving, flower making flower bouquets (guldasta) making, zari making, handcraft, Applik and paunch making, weaving, jewellery making, fabric painting, pot painting, glass painting, soft toys, mobile Repairing, CCC, BCC, O Level, BTC etc.
- 3.25 To open and run the Govt. program like NSDC, CSC, DUDA, SUDA, CAPART, NABARD, NAREGA, SIFPSA, Jan Sewa Kendra (UPCSC, Lok Vars Kendr & Pradhanmantri Kaushal Vikas Yojna (PMKVY) for skill India.
- 3.26 To establish and maintain institution for the handicapped, blind, deaf, dumb, poor, SC, ST, Minorities, Backward Classes and other needy people to provide the training of house hold Industries, semi-skilled jobs and also to provide them other required facilities like hostels, Medical Aid, food cloths, Transportation and economic assistance to start new business, as per Govt. Policy

- 3.27 To promote, organize, administer, establish, maintain and or grant and to nay person, institution of the trust or organization whatsoever having for the object of charitable purpose and to incur expenditure in connection therewith.
- 3.28 To make best efforts to provide security, shelter respect, employment and other required/ necessary facilities to the prostitutes and their dependent children.
- 3.29 To publish Books, charts, illustrations, journals, Magazines, Periodicals, News Letter/Papers and other Publications in the different language and on the different subjects.
- 3.30 To run and motivate the awareness program for Road Safety & Highway Management Safety.
- 3.31 To provide help and motivate to mentally restarted people.
- 3.32 To promote health and hygiene through yoga, naturopathy, Ayurveda, acupressure, acupuncture and other traditional medical therapy.
- 3.33 To run, manage, and promote the environmental safety management and awareness program and do the best efforts for the protection of animal's birds, forest, river and all other natural resources.
- 3.34 To encourage all kind of Games/ Sports like Yoga, hockey, football, cricket and other National and International Games/ Sports for Improvement of health amongst the youth and children on the whole and organize tournaments Yoga & Sports Competition on Block, district, State, national and International Level.
- 3.35 To collect information, notifications, policies for the Government, Semi-Government, National/ International Agencies and N G O's and also provide the same to the members of the Trust and The General Public.
- 3.36 To provide legal medical and social economics help and assistance to the needy people at free of cost.
- 3.37 To organize and raise funds and or the donations towards the CM/PM relief Funds
- 3.38 To assists and Co-operate the other Associations Trusts and the various N G O's whose aims are same like this Trust.

- 3.39 To celebrate annual day of the trust every year as cultural & social event.
- 3.40 To do such other things/acts/activities which are necessary and which may be incidental or conducive to the attainment of any other object of the Trust.
- 3.41 The Aims and Objects of The Trust Shall be purely for "Charitable Purpose" which includes relief of the poor, educational, social, medical relief and the advancement of any other objects of general Public Utility.
- 3.42 To carry on any lawful activity for raising funds for the purpose of the Trust.

#### 4. BOARD OF TRUSTEES

- 4.1 The Author and Founder of the Trust shall be the 1st Trustees. They shall also be designated as the Founder Trustees
- 4.2 To manage the properties, assets and funds of the Trust, from time to time, such regulations (not being inconsistent with this deed) as they may think fit for and necessary for the purposes of such management and control or in connection with the execution of any of the subject herein contained or powers hereby vested in them and may rescind or alter any such regulation.
- 4.3 To appoint a managing Trustee, when necessary.
- 4.4 To review the affairs of the Trust and a necessary.

#### 5. FUNDS:

The Trustees may accept donations, grants, subscriptions, aids or contributions from any person, government Local authorities or any other charitable Institutions, in cash or Kind including immovable property without any encumbrance, but the trustees shall not accept any receipt with any condition or Term inconsistent with the object of Trust. While applying such receipt to the object, the trustees shall respect the directions, if any, by the granter. Any receipt with specific direction to treat the same as part of the corpus of the trust or separate fund shall be funded accordingly.

## 6. INVESTMENTS:

- 6.1 All monies, which shall not immediately require for current needs shall be invested by the trustees in eligible securities and investment, or in banks. Such investments shall be in the name of Trust.
- 6.2 That the trustees shall invest the trust fund; carry on any business with the trust fund and/or enter into partnership on behalf of the trust, as they may deem fit.
- 6.3 That the trustees shall manage the trust fund and investment thereof as a prudent man would do the same. They shall recover all outstanding and meet all recurring and other expenses, incurred in the upkeep or management thereof.
- 6.4 That the trustees shall receive and hold the income of the trust on behalf and for the benefit of the beneficiaries the trust.

## 7. POWERS, FUNCTIONS AND DUTIES OF THE TRUSTEES:

- 7.1 All property of the Trust Movable or Immovable or of any other kind, shall vest in trust, the trustees shall manage the whole property and affairs of the trust and shall have all powers, duties and functions necessary proper and incidental to the promotion and carrying out of the objects of the trust.
- 7.2 In particular and without prejudice to the generality of the foregoing the trustees shall for the purposes of this trust have the following powers, Duties and Functions:
  - 7.2.1 To acquire by Gift, Grant, Purchase, Exchange, Lease, or otherwise, lands, buildings, or other immovable properties and also any Movable Property.
  - 7.2.2 To construct and maintain buildings, to alter, to demolish or improve them and equip them suitably.

- 7.2.3 To accept gifts, donations, endowment and contributions for the Trust and shall be treated as the income of the Trust.
- 7.2.4 To rise loans, to receive monies, securities or other movable property on behalf of the Trust.
- 7.2.5 To accept any trust, trust fund or endowment so long as the provisions of such Trust or endowment are in consonance with the objects of this Trust.
- 7.2.6 To award scholarship and make donations calculated to promote the objects of the Trust.
- 7.2.7 To enter into contracts, or engagements on behalf of the Trust.
- 7.2.8 To consider such proposals submitted by sub-committee appointed by this trust and allocate such funds if necessary as deemed necessary for the implementation of the programs.
- 7.2.9 To make, sign and execute all such documents instruments, as may be necessary or proper for carrying on the management of the properties and affairs of the Trust.
- 7.2.10 To invest such monies and such funds of the trust and to vary the investment as and when it may seem necessary or proper provided that such investments shall be made only upon immovable properties or upon securities as the board of trustee may deem fit, under section 20 of the Indian Trust Act, 1882.
- 7.2.11 To sell, transfer or otherwise dispose of any immovable property of the trust provided all the trustees unanimously resolve that it is in the interest of the trust to do so to sell or lease, mortgage or otherwise dispose of any movable and immovable properties of the Trust.
- 7.2.12 To appoint Committee/Committees of management for such terms and with such powers as may be specified from time to time, for carrying on the routine management of the affairs of the Trust.

- 7.2.13 To appoint such employees on such terms and conditions as the Trustees may deem fit for carrying out the work of the trust and exercise control all such employees including the power of suspension, dismissal and removal.
- 7.2.14 To delegate to the managing Trustee or any appointed committee such powers, duties and functions as are vested in the Trustees.
- 7.2.15 To frame Bye Laws and such other regulations as are required for achieving its objectives.
- 7.3 Out of the income of the trust property the trustee shall be entitled to spend or incur the following expenses namely
- 7.3.1 All rates, taxes, cess, assessments, dues and duties if any payable to the government to any municipal or other public bodies in respect thereof or any part thereof.
- 7.3.2 The premium for the insurance of the buildings or any other insurable property movable or immovable for the time being forming part of the trust property.
- 7.3.3 The costs of ordinary repairs and for providing any amenities to the buildings for the time being forming part of the trust property.
- 7.3.4 The cost of making such additions/alterations or improvements to or in the buildings forming part of the trust property, as the trustees shall think fit.
- 7.3.5 Wages and salaries of any manager, supervisor, accountant, clerk, servant or other employees employed by the trustees in the carrying out of this trust.
- 7.3.6 Cost and expenses of keeping the trust property in good condition.

- 7.3.7 Cost and expenses for installing and renovating the electrical and other installations in the building for the time being forming part of the trust property.
- 7.3.8 The architect's fee and legal charges and fee payable to other professionals engaged in the course of administration of the trust.
- 7.3.9 All other costs, charges and expenses of and incidental to the management and administration of the trust property in accordance with the objects and purposes hereof or which may be incidental thereto.
- 7.4 After deducting the costs charges and expenses incurred by the trustee's as aforesaid out of the total gross income received by them from the trust property the balance that is the net income will be utilized for the objects of the trust has decided by the board of trustees.

## 8. BOOK ACCOUNT:

- 8.1 To open any type of bank account (s) weather saving account, current account, fixed or otherwise, in the name of the Trust or institution (s) or program (s) run by the Trust with any scheduled banks (s) or post office (s) or any nationalized and any private bank and to operate by the authorized signatory or signatories as Board of Trustees shall think fit and proper to authorize any person or persons, unless and until determined otherwise the such bank account(s) shall be opened and managed and operate by either or Survivor or mutually decide by the Trustee of the trust on time by time
- 8.2 All income, subscription and pecuniary donations for the general purposes of the trust and the income, investments and all other moneys from time to time forming part of the general revenue of the Trust shall on the same being received be paid into a banking account with any Nationalized and private banks or any other bank for the purpose of the Trust. The Bank Account shall be managed and operate by either or Survivor or mutually decide by the Trustee of the trust on time by time.

## 9. ACCOUNTS AND AUDIT:

## 10. IRREVOCAABILITY:

The Trust is irrevocable.

## 11. ACTIVITIES OF THE TRUST:

The activities of the Trust shall be only within India and its Union territories and shall not be extended anywhere outside India.

## 12. DEFECTS OF PROCEDURE IMMATERIAL:

No act of Trustees shall be invalidated by reason only of any vacancy in the Board of Trustees or any irregularity in the proceedings of the Board of Trustees or any Committee thereof.

## 13. AMENDMENTS:

No amendments to the Trust Deed shall be made which may prove to be repugnant to the provisions of Section 2(15), 11, 12 and 13 and 80G of the Income Tax Act, 1961 as amended from time to time.




